WALTZING MATILDA (IRE) away without apparent mishap, took up residence in the two path in the middle of the field, proved ratable while between rivals for a good portion of the way to the quarter pole, tipped a bit wider into the stretch and was given her cue turning for home, chopped away readily at the deficit during the ensuing furlong, drew even with about a sixteenth remaining, took charge after a couple of more jumps, dug in with good determination in the final stages to stave off the runner up. EASTERN BELLE (GB) had the pilot take hold after stumbling inward in an awkward manner, loped along taking the two path, picked up interest commencing to get angled outward from the five-sixteenths marker, wound up in the seven path by the conclusion of the maneuver, kicked into stride once straightened away, charged down the outside of the course with a rush to garner the place. KITTEN'S QUEEN established control almost instantaneously, was nibbling on the bit, but otherwise rating kindly carving out the pace, felt an uptick in pressure in pressure from the closest pursuer, that being SELENITE after the second fraction had been recorded, drifted into the two path getting switched over to stronger handling heading for the top of the lane, relinquished in the vicinity of the sixteenth pole, proved no match for the second place finisher soon afterwards and had to settle for the show. STEPHANIE'S KITTEN underwent a four wide journey to the quarter pole, continued on with good courage down the stretch for the last major check. WHITE ROSE quicked tucked along the hedge, saved ground to the quarter pole, mustered up a mild response after getting angled out. BEAUTY PARLOR tracked the pacesetter taking the inside route, faltered. RIPOSTE (GB) travelled three wide on both turns, made no impact. MAXIMOVA strung out three wide on the clubhouse turn, was as wide on the subsequent one as well, got outrun. SELENITE stalked KITTEN'S QUEEN from the two path for the opening mile and gave way.
