Supplementary nominations may be made by closing time of entries at a fee of \$1,500 which qualifies to start with \$100,000 Guaranteed with 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: 122 lbs. Non-winners of \$50,000 in 2015 allowed 3 lbs.; \$35,000 at any time allowed 5 lbs.; \$25,000 in 2015 allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner will receive a trophy. Closed Thursday, April 2, 2015 with 40 nominees. (Cloudy 70)

WOLF MAN ROCKET last away, raced back and outside, advanced four wide second turn, floated out by the winner entering the stretch, engaged that one soon after, proved best under steady handling. HILLBILLY ROYALTY broke on top, got clear before a quarter, continued to show the way up the backstretch while lightly rated, came out a bit to float the winner out turning for home, could not match that foe late, clear of the rest. POSEIDON'S WAY firmly rated off the pace, in some traffic while in hand up the backstretch, five wide into the lane, up for the show, no match for the top two. SUPERMASON closest to the leader, asked along in the second turn, had little left, outkicked for the show. BIG BIG EASY void of speed, continued to trail into the stretch, displayed a modest amount of late interest to pick up a couple of spots, no real threat. BUBBA ROAN within striking distance along the inside, bit closer late backstretch, had little left for the drive. HOLIDAY MAN in the second flight while racing three wide, weakened.
