DADDY D T chased inside, came out into the stretch and again in upper stretch and rallied under urging to get up late. SKY PREACHER stalked outside a rival then three deep, came four wide into the stretch and rallied between foes. PAPACOOLPAPACOOL saved ground stalking the pace, bid between horses past the eighth pole and also went on willingly late. DALLAS SKYLINE chased outside a rival, went up three wide to the lead on the backstretch, dueled three deep on the second turn and into the stretch and was outfinished. PIONEER OF THE WEST had good early speed and angled in, dueled inside, regained the advantage into the second turn, inched away in midstretch, fought back in deep stretch and also was outfinished. HIGHWAY BOSS chased outside a rival or off the rail, swung four wide into the stretch and found his best stride late. PEACENLUVPEACENLUV pulled and dueled outside a rival, bid again between foes into and on the second turn and into the stretch and weakened. LITIGATION ROAD steadied at the start, settled inside then outside a rival, angled in on the second turn and did not rally. CONQUEST BESPOKE angled in and saved ground chasing the pace, dropped back on the second turn and weakened.
