A supplemental nomination payment of \$8,000 in addition to the entry fee can be made at any time prior to the publication of weights. All starters including supplemental nominees to receive a \$2,000 rebate. The purse will be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Trophies will be presented to the winning owner, trainer and jockey. Closed Saturday, May 11, 2013 with 16 Nominations. (Clear 70)

TIZ MIZ SUE patiently tracked the front runners while taking the inside route, picked up interest after a bit more halfway around the turn, was taken outward, loosely drafted behind the second place finisher from the two path for a few strides after turning for home, altered course to be outside that rival and after getting set down took off in earnest, forged her way to a slim advantage with an eighth remaining, battled intensely with a resolute AUTHENCITY the rest of the way to the wire, dug in gamely to prove best. AUTHENTICITY prompted the pacesetter from the two path, moved when ready and took over the lead in the vicinity of the five-sixteenths pole, doing so under her own power, entered the stretch with a full length advantage, got pounced upon by the winner shortly afterwards and was let out in response to the challenge, fell back by a sliver during the ensuing sixteenth, fought with vigor but couldn't reclaim the front. CENTRING rated along the rail for the opening three-quarters, was given her cue and angled sharply four wide into the stretch, settled into her best stride nearing the furlong marker, charged at the first two finishers with good, but belated energy en route for the show. DISPOSABLEPLEASURE chased three wide, failed to respond when roused at the three-eighths pole and tired. JOYFUL VICTORY put to some light hand urging, edged away to a narrow advantage, cut the pace being rated along, had AUTHENCITY draw up and issue a bid for command leaving the midway point on the turn, yielded despite getting asked for some run, steadily tired after entering the stretch. BELIEVE YOU CAN chased the front runners along the outside under some urging on the turn, gave way.
