TONITO M. well placed early from the outside, tracked the pace up the backstretch, advanced entering the second turn, responded when asked and wore down rivals the final furlong. BAY OF BISCAY up close early from the outside, chased the pace up the backstretch, reached a forward position entering the second turn, gained the margin but could not last. WILDCAT RED up close early from the inside, forced the pace up the backstretch, held a forward position for the drive but had no late response. LOUIES FLOWER broke sharp from the outside, gained a clear early margin, dueled up the backstretch, remained engaged through the second turn then tired. CHARGE NOW could only improve position. FOR GOODNESS SAKE forced the early pace outside but had no late response. IBAKA chased the early pace and tired. STREET PRANCER was no factor. AWAY GAME chased the early pace but had nothing left. TULUM (MEX) was never close. EVEN ECHO had little interest. EDISON was no threat. REBRANDED was never a factor. DECLAN'S FAST CAT was never close.
