By subscription of \$150 each by Wednesday January 2,2008, which shall accompany the nomination, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed. (\$50,000 from the F.T.B.O.A. Fund to be divided, 60% to the winner, 20% to second, and 10% to third, 5% to fourth,3% to fifth and 2% to sixth Registered Florida Breds placing First, Second, Third, Fourth,Fifth or sixth.) The owner of the winner to receive \$60,000, \$20,000 to second, \$10,000 to third, \$5,000 to fourth,\$3,000 to fifth and \$2,000 to sixth. GAME FACE rated off the pace, made a quick move four wide on the turn to reach the leaders while still in hand, gained command at the top of the stretch and drew off when asked. **MELISSA JO** tracked the pace, was boxed in around the turn, angled out for the drive and closed to prove second best while no match for the winner. **ORINOQUIA** unhurried after breaking slowly, passed tired rivals for the show. **COZY MESA** allowed to settle, improved her position in the drive without threatening. **INDY'S ALEXANDRA** chased the pace along the inside into the stretch, then gave way. **THROBBIN' HEART** pressed the pace outside **LOVELY ISLE** to the top of the stretch, then tired. **LOVELY ISLE** set the pace under pressure along the rail to the top of the stretch, then faltered. **A LITTLE GEM** chased the leaders three wide around the turn and faded. **ELUSIVE LADY** steadied when caught in too close to the rail leaving the gap and was outrun.
