ORB raced in tight going into the first turn, steadied slightly and raced in the back in opening quarter, continued to pull in early stages, forced to settle in under patient handling, given permission to pick up the pace in the backstretch, edged up to the leader near the quarter pole, matched strides with DUKE OF THE CITY into the stretch, shook free in the final sixteenth and continued clear to the wire. DUKE OF THE CITY broke on top and took the lead in the first turn, continued to set the pace by a slight margin over rival, was challenged by ORB nearing the far turn, matched strides along the inside of rival into the lane, could not keep up the pace in the final furlong and finished second best. INDY'S ILLUSION stalked between rivals in early stages, settled back slightly along the rail, began to pick up the pace nearing the quarter pole, saved ground along the rail in the turn and continued a steady bid for leaders in the drive. MOUNTAIN EAGLE raced just off the leader in opening stages, continued to press the pace in the backstretch, inched up to the lead nearing the far turn, could not keep up the pace, raced three wide in the far turn and steadily weakened in the drive. UPTOWN ANTHEM tracked the pace three deep in the backstretch, urged to pick up the pace heading for home, raced three wide in the far turn and lacked response in the drive. LOOKING COOL settled in behind front runners in the backstretch, asked for response nearing the far turn and failed to respond in the stretch. SAYLER'S CREEK stalked the pace along the rail in opening stages, gave way after a half mile and was eased up in the stretch.
