BURST AWAY settled while racing well out from the inside, moved to the front from the outside nearing the end of the backstretch, drew clear early on the far turn, bore out under left hand whip leaving the furlong grounds, was straightened away and held under steady urging. DANCING SPARKS was unhurried following a slow break, stayed along the rail around the final turn and while gaining through the lane. DELICATE GENIUS set or forced the pace along the rail, fell back on the final turn, came out to vie outside the winner into the final furlong, angled out when that one bore out and weakened to finish in a dead heat for third. SYLVIA'S SWEETART was unhurried inside, began a run into the far turn, came out for the drive, angled out entering the final furlong and hung while finishing even for the show. THICKET was unhurried early, raced three wide between rivals into the stretch and gained mildly. PROPER HEIRESS was unhurried, raced two wide between rivals around the final turn and gained mildly. ARTIE'S PARTY was slow early, raced wide into the stretch and failed to menace. ESPIGA was outrun. QUEEN ANNA dueled two wide to the end of the backstretch then stopped and was eased up late. COME ON ROSE pulled up lame on the final turn and was vanned off.
