5 FURLONGS. (Turf) (.543) STAKES. Purse \$150,000 *PENNSYLVANIA GOVERNOR'S CUP H. FOR THREE-YEAR-OLDS AND UPWARD.* No Nomination Fee, \$750 to pass the entry box, \$750 additional to start. Supplemental Nominations of \$3,000 will be accepted at time of entry which shall include all fees. The purse to be distributed: \$1,500 to all starters, with the balance of the purse to be divided; 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. Weights: Three Year Olds, 118 lbs.: Older: 122 lbs. Non-winners of a Sweepstakes on the turf in 2012-2013, allowed 3 lbs. (Preference to starters will be in the following order: First preference will go to Graded Stakes Winners in 2012-2013, Second preference to Stakes Winners on the turf and Graded Stakes Placed horses in 2012-2013, Third preference to horses with the highest total earnings in non-claiming races in 2012-2013). Rail at 0 feet. Closed May 22 with 41 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at Five Furlongs.). (Clear 90)

TIGHTEND TOUCHDOWN set the pace soon after the start, gained command on the turn while saving ground, then finished under mild encouragement. BRIDGETOWN stalked the pace from the two path through the turn, then was no match for the winner in the drive. BEN'S CAT was close up and three wide into the turn, was forced wide and had to check abruptly, then made a late gain for a share. KYMA was close up and two wide on the turn, then bore out and interfered with rivals on the outside, an inquiry was posted by the stewards and an objection, after review the stewards disqualified KYMA for interference with SNOW LEOPARD and placed KYMA last. CATALACTIC showed speed early, raced inside on the turn, then weakened in the drive. ICON IKE was slow early, saved ground on the turn, then made a mild bid in the lane. FIFTY TOO pressed the pace from along the inside through the turn, then faded late. TIEMPO LIBRE was void of early speed, raced three wide on the turn, then lacked a rally. CHAMBERLAIN BRIDGE was close early, raced three wide and was forced to check on the turn then faded. SNOW LEOPARD pressed the pace into the turn, then was forced wide and gave way.
