1 1/2 MILES. (Turf) (2.23) STAKES. Purse \$150,000 PAN AMERICAN S. (GRADE III) FOR FOUR YEAR OLDS AND UPWARD. Free nomination by Saturday, March 13, 2010, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$ 90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be made at time of entry at a fee of \$6,000, which includes entry and starting fees. Weight: 123 lbs. Non-winners of a grade I or II stakes over nine furlongs on the turf in 2009-2010 allowed 2 lbs.; a sweepstakes over nine furlongs in 2009-2010 4 lbs., \$45,000 over nine furlongs since September 1, 6 lbs. In the event this stakes is taken off the turf, it may be subject to downing rading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, March 13, 2009 with 31 nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Quarter) (Rail at 84 feet). (Clear 78)

Bay Gelding, (Feb), by Dynaformer - Song 'n Silk by Unbridled's Song. Trainer Wilkes R. Ian. Bred by Whisper Hill Farm(KY). BEARPATH stalked the pacesetter into the stretch the final time, rallied to catch that rival inside the eighth pole and was fully extended to prevail. NEVER ON SUNDAY (FR) reserved into the final turn, angled out for the stretch run and rallied to be up for the place. BROTHER NICK well in hand while making the pace, responded when challenged in the stretch, then gave way grudgingly. WINCHESTER taken in hand to stalk the pace, lacked room in behind rivals on the final turn, angled in and had no response when asked. UNCLE INDY rated off the pace for more than a mile, advanced three wide around the final turn to reach contention, then weakened in the drive. LEMON SPICE steadied repeatedly along the rail for the first six furlongs, continued to save ground into the stretch, angled out and lacked a rally. SILVER MOUNTAIN tracked the leaders along the rail into the stretch the final time, then tired. BRASS HAT steadied when he bumped with MEMORIAL MANIAC at the start and was not a factor. MEMORIAL MANIAC trailed after being steadied when he bumped with BRASS HAT at the start.
