ROMAN INVADER put to light hand urging after the start, gained control shortly after departing the chute, was rated along the inside while cutting the pace, edged away from the competition during the later stages of the run around the bend, spun into the stretch and was soon asked for a response, left the furlong grounds, holding her biggest advantage, staved off the belated bids coming from the closest pursuers in the last eighth to prove best. STREET SECRET brushed at the start, stalked the winner from the outside, was let out a notch at the half mile pole but failed to increase the pressure, made up some ground belatedly while protecting the place. SEA ISLAND saved ground until the quarter pole, was put to brisk encouragement angling three wide into the stretch, proved no match. MOON PHILLY lost her footing at the start, initiating light contact with the runner up, raced from off the inside, was three wide and under a drive midway on the turn, failed to respond to it and gave way.
