FORCE THE PASS settled two wide between horses, lacked room approaching the la e, angled out when set down entering the stretch and rallied to the front in the final yards. NIGHT PROWLER was unhurried, rallied four wide around the final turn, took over entering the final furlong, held gamely to the final yards but gave way. GRANNY'S KITTEN was caught in tight along the inside on the backstretch, was in tight in early stretch, came out between horses and was gaining when bumped into GALLERY in late stretch. OCHO OCHO OCHO wasn't far back inside, came out between rivals for the drive and finished willingly. MY POINT EXACTLY settled between horses, raced two wide around the final turn then closed between horses in the lane, came in and bumped GRANNY'S KITCHEN late. HIGH NOON RIDER was slow to settle, raced wide around the final turn and gained too late between horses. PAPACOOLPAPACOOOL was slow early while inside, rallied wide around the final turn and made up ground late between horses. GALLERY pressed the pace two wide, took over entering the far turn and was tiring when bumped by GRANNY'S KITCHEN in late stretch. COMANCHE'S STORM made the pace along the rail into the far turn and tired in the lane. WOODWIN W was outrun. TUBA ran out while showing speed into the first turn, remained in good position outside to the far turn then stopped.
