ESKENDEREYA trailed in hand early, was unhurried for a half, waited behind horses midway on the turn, split horses to launch his bid at the quarter pole, opened a clear advantage in midstretch and drew off with authority under steady right hand urging. WESTERN FLYER pressed the pace from outside for five furlongs, gained a brief lead at the quarter pole but was no match for the winner while holding well for the place. CHAIRMAN NOW stalked the pace from outside, lodged a three wide move on the turn then closed mildly to gain a share. BRICKLAYER rushed up inside, dueled along the rail to the top of the stretch and steadily tired thereafter. DEAN'S KITTEN never reached contention.
