**Bay Gelding, (Apr), by Northern Afleet - Wilshe Amaze by In Excess (IRE). Trainer Spawr William. Bred by Gregg Anderson(CA).**  
**AMAZOMBIE** between horses early, stalked outside a rival on the backstretch and turn, came out four wide into the stretch and rallied under urging to prevail late. **CAPTAIN CHEROKEE** had speed between foes then stalked off the rail, came out three deep into the stretch, split rivals with a rally past midstretch to put a head in front in deep stretch and continued willingly. **VENTANA** stalked the pace four wide then bid three deep into and on the turn, battled outside a rival in the stretch, could not match the top pair late but edged **M ONE RIFLE** for the show. **M ONE RIFLE** had good early speed and inched away on the backstretch, set the pace a bit off the rail, angled in and dueled inside into and on the turn, fought back to a short lead in the stretch, drifted out a bit then in late and was edged for third. **DON TITO** settled outside a rival then saved ground off the pace, went around a foe into the stretch and lacked the needed rally. **CHOCOLATE CANDY** a bit slow to begin, settled just off the rail then angled in on the turn, came out around a foe in the stretch, angled back to the fence and found his best stride late while in a bit tight off heels on the wire. **CROWN OF THORNS** chased off the rail then briefly between horses on the backstretch, continued off the inside on the turn and four wide into the stretch and did not rally. **BET ON VICTOR** broke outward, stalked early then bid between horses into the turn, put a head in front on the bend, but weakened in the stretch. **COLGAN'S CHIP** allowed to settle outside chasing the pace, came five wide into the stretch and lacked the necessary response. **ATTA BOY ROY** broke a bit slowly, went up inside to stalk the pace, dropped back on the turn and weakened in the stretch.
