ETUDE stalked the pace, circled the turn, gained the lead in upper stretch under confident handling and eagerly pulled away under a hearty hand ride. SARATOGA LULABY came in at the break, pressed the pace outside JOHNNY Z. drifted out near the sixteenth pole and finished gamely. NOT FOR MONEY raced in the two path, was steadied behind SARATOGA LULABY near the sixteenth pole and rallied. CHEROKEE COUNTRY , unhurried early, raced wide on the turn, failed to sustain his bid and was brushed by SARATOGA LULABY inside the sixteenth pole. BRASS RUN lacked speed, swung five wide near the quarter pole and passed tired ones. ANOTHER VOW was no factor. MY THREE BOYS , sent early, raced along the rail and gave way. JOHNNY Z. , bumped leaving the starting gate, set the pace along the rail and gave way. WEST COAST FLIER raced in the two path on the turn and fell back. An objection by the rider of NOT FOR MONEY against SARATOGA LULABY for alleged interference in the stretch was not allowed.
