NANA ANNA, sent to the early lead, set the pace along the rail, opened up on the turn then was kept to her business in the drive. HENNY'S PRINCESS stumbled leaving the starting gate, chased the winner while three deep on the turn and finished gamely. WINDSOR'S GRADUATE, forced in on CITY EXIT by HILLS OF GOLD soon after the break, saved ground on the turn, angled out near the sixteenth pole and rallied. CAT THATS GREY bumped ALWAYS REMARKABLE when bearing in at the break, prompted the pace outside the winner and weakened. ROY'S EAGLE, wide entering the stretch, failed to rally. HILL'S OF GOLD drifted in on rivals soon after the break causing MARY BOPPINS to be impeded, raced three deep on the turn and failed to rally in an even effort. CITY EXIT, forced in soon after the break, was outrun. ALWAYS REMARKABLE, checked when bumped by CAT THATS GREY leaving the starting gate, was outrun. MARY BOPPINS broke slowly then was checked in tight quarters soon after the start. BOSTON BANSHEE was outrun. Following a stewards' inquiry, CAT THATS GREY was disqualified and place eighth and HILLS OF GOLD was disqualified and placed ninth for impeding rivals leaving the starting gate.
