1 1/4 MILES. (1.473) STAKES. Purse \$150,000 *RAMPART S. (GRADE III) FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD.* Free nomination by Saturday, March 19, 2011, \$1,500 to pass the entry box and \$750 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000; \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be made at time of entry at a fee of \$7,500, which includes entry and starting fees. Weight: 123 lbs. Non-winners of a grade/group I or II stakes at a mile or over in 2011 allowed 2 lbs; of a graded stakes at a mile or over since August 1, 4 lbs., of two races other than maiden or claiming at a mile or over since September 1, 6 lbs. Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 Starters, with Also Eligibles. If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners, then highest 2009-2011 earnings. Trophy too winning owner. Closed Saturday, March 19, 2011 with 23 nominations. (Clear 82)

AWESOME MARIA stalked the pace four wide, moved to gain command midway of the far turn, then drew off through the stretch under urging. SUCCESSFUL SONG reserved racing along the rail, rallied to reach the attending position on the far turn but was no match for the winner while holding the place. UNRIVALED BELLE stalked the pace three wide outside PERSUADING to midway of the far turn, then tired. PERSUADING quickly moved to the fore off the rail, was hard to handle while trying to drift out on both turns, made the pace to midway of the far turn, then faltered. STEPHANIE GOT EVEN was not a factor. DUBAI DANCER was done early and eased in the stretch run.
