THE SIXTIES (GB) closest to the pace, challenged from the three path on the turn, took over for the drive and drew off under steady urging. RESTRICTED LIST within striking distance off the inside, split rivals in midstretch and finished willingly to be second best. ALEXANDER THEGREAT within reach off the inside, moved closest to the winner with a furlong to go but tired late. ARGUMENTAL outrun early, raced four wide with three furlongs to go and was no threat. GLADHANDER forwardly placed four wide, tired in the drive. BOOSTER ROCKET set the pace off the inside, held on well to the stretch and tired. OUR FRIEND HARRY was no threat while five wide. GOVERNMENT ROAD was outrun in the four path. TURN AND RUN close up early, dropped back into the stretch, was eased and vanned off.
