PARRANDA five wide early, angled in and stalked the pace off the rail, went between horses nearing the half mile pole then was taken back, angled three wide into the stretch, bid outside the runner-up, gained the advantage under urging in late stretch and gamely prevailed. KATHLEEN ROSE had speed outside then angled in and set the pace inside, dueled leaving the backstretch and on the second turn, fought back along the rail through the final furlong and went willingly to the wire. MOULIN DE MOUGIN stalked between horses then outside, went three deep on the second turn and four wide into the stretch, drifted in some and held third. WISHING GATE bumped at the start, settled off the rail, came out in the stretch and just missed the show. DANCINGTOTHESTARS close up stalking the pace inside, came out a bit into the stretch then angled back to the rail and lacked the needed late kick. MOONE'S MY NAME (GB) bumped at the start, chased between horses, steadied in a bit tight midway on the second turn, angled to the rail into the stretch, came out in midstretch and could not summon the necessary response. STORMY LUCY saved ground chasing the pace, came out leaving the second turn and four wide into the stretch and lacked the needed rally. HABIBI (NZ) bumped at the break, pulled some and chased three deep, swung five wide into the stretch and did not rally. REDRESSTHEBALANCE (IRE) also bumped at the start, chased between horses then three deep or outside a rival, fell back leaving the second turn and weakened. DUTCHESSA (GB) pulled three deep chasing the pace then bid three wide leaving the backstretch, dueled outside the runner-up into and on the second turn, was between horses into the stretch and also weakened.
