1 1/4 MILES. (Inner Turf) (1.45) STAKES. Purse \$150,000 SANDS POINT S. (GRADE II) INNER TURF FOR FILLIES THREE YEARS OLD. No nomination fee. \$1,500 to pass the entry box. All starters to receive a \$1,000 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 123 lbs. TURF: Non-winners of a Graded Sweepstake twice on the turf allowed 2 lbs.; such a race; or a Sweepstake on the turf in 2009, 4 lbs.; two races at a mile or over on the turf, 6 lbs. DIRT: Non-winners of a Sweepstake at a mile or over on the dirt allowed 2 lbs.; two races at a mile or over on the dirt, 4 lbs.; \$36,000; or a race at a mile or over on the dirt, 6 lbs. (Maiden, claiming and restricted races not considered in allowances). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race of the Main Track. In the event that this race is taken off the turf, dirt allowances will apply and it may be subject to downgrading upon review by the Graded Stakes Committee. GOZZIP GIRL took command soon after the start, set moderate fractions under rating tactics in the two path, ducked inward midway during the run around the second bend, responded positively when put to encouragement turning for home, maintaining a safe margin during the stretch drive under steady urging. WARM SHOWER sat well placed along the inside under a firm hold, was forced to await racing room approaching the quarter pole, angled outward upon gaining clearance in the vicinity of the three-sixteenths pole, commenced her rally when set down and finished with good energy to garner place honors. BLUEGRASS PRINCESS saved ground until midway along the backstretch, prompted the pacesetter until nearing the top of the stretch, was asked for a bit more in upper stretch, proved no match but held well enough to secure the show. MAGICAL AFFAIR reserved along the outside, was fanned four wide into the lane and displayed a mild rally. FAST TIGRESS rated along the inside, was no factor. HOPEFUL IMAGE between rivals, gave way after going three-quarters. SAPPHIRE SKY raced three wide around both turns and tired.
