TAPIZAR pulled his way along four wide then three deep into the first turn to take the lead, angled in and inched away, set the pace a bit off the rail to the stretch, continued toward the inside and won clear under some left handed urging. BALLADRY settled off the pace inside, came out a bit on the second turn, angled out three deep into the stretch and just got the place. PRAYER FOR RELIEF had speed inside then saved ground stalking the pace, came out leaving the second turn and into the stretch and was edged late for second. RIVETING REASON stalked outside a rival, also came out into the stretch and weakened. SPUD SPIVENS wide into the first turn, chased outside, came out five wide into the stretch and did not rally. IRISH ART three deep between foes early, settled outside a rival chasing the pace, came out on the second turn, was fanned six wide into the stretch and lacked a further response. FIRST STRIKE hopped and was squeezed at the start, pulled four wide into the first turn, angled in on that bend, chased a bit off the rail leaving the backstretch, came out on the second turn and four wide into the stretch, drifted inward in the drive and weakened.
