Non-winners of a Grade I or Grade II stake at One Mile or Over since July 3, 2014, allowed 3 lbs.; Non-winners of a Grade I or Grade II stake at One Mile or Over OR Two Grade III stakes at One Mile or Over since January 3, 2014, allowed 5 lbs. FINNEGANS WAKE squeezed some at the start, settled off the rail then outside a rival, came out four wide into the stretch, rallied under urging to the lead in deep stretch and held gamely. PATRIOTICANDPROUD between horses early, chased inside, came out into the stretch and again in upper stretch and finished well to gain the place late. POWER PED pulled between rivals early, chased outside a foe, came out leaving the second turn and four wide into the stretch, bid outside in the drive then between horses in deep stretch and held third. TOM'S TRIBUTE four wide early, stalked outside a rival then bid three deep on the backstretch and second turn and into the stretch, continued between horses in the drive and was outfinished. SKYRING dueled outside a rival then between foes, took a short lead in the stretch, fought back between horses in the drive and also was outfinished. DYNAMIC SKY saved ground chasing the pace, lacked room behind rivals in midstretch, split horses in deep stretch and continued willingly. BIG BANE THEORY pulled early, stalked inside, came out into the stretch, awaited room behind foes in midstretch and lacked the needed late kick. EDGE OF REALITY had good early speed and dueled inside, fought back in the stretch and weakened late.
