6 FURLONGS. (1.074) STAKES. Purse \$100,000 SAYLORVILLE S. FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Three-Year-Olds - 118 lbs.; Older - 123 lbs. Non-winners of \$40,000 other than maiden or claiming in 2010 allowed 3 lbs.; non-winners of \$24,000 once or \$18,000 twice other than maiden or claiming in 2010 all owed 5 lbs.; \$20,000 once or \$10,000 twice other than maiden or claiming in 2010 allowed 7 lbs.; \$12,000 once or \$7,200 twice other than maiden or claiming in 2010 allowed 9 lbs. No nomination fee. \$750 to pass the entry box and \$750 additional to start. \$100,000 guaranteed of which 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$2,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds fourteen (14), high weights will be preferred. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. (Clear 77)

SECRET GYPSY stalked the early pace from the outside, inched closer entering the turn, responded when sat down for the drive to gain a clear advantage at the eighth pole and was well clear while kept to task. MINDY QUEEN well placed from between foes early, forced the early pace, dueled through the turn, remained forward through the drive but was no match for the winner while holding position. PALANKA CITY chased the early pace from the outside, advanced entering the turn, responded and had a mild late gain. MARGIE MARIE dueled from the inside early, gained a clear margin entering the turn, dueled through the turn, remained in a forward position entering the drive but tired late. SIMPLIFY was no real threat. NO FLIES ON DOODLE forced the early pace from just off the rail but had nothing left for the drive.
