6 FURLONGS. (1.071) STAKES. Purse \$100,000 SAYLORVILLE S. FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Three-Year-Olds - 118 lbs.; Older - 123 lbs. Non-winners of \$40,000 other than maiden or claiming in 2013 allowed 3 lbs.; non-winners of \$24,000 once or \$18,000 twice other than maiden or claiming in 2013 all owed 5 lbs.; \$20,000 once or \$10,000 twice other than maiden or claiming in 2013 allowed 7 lbs.; \$12,000 once or \$7,200 twice other than maiden or claiming in 2013 allowed 9 lbs.
