WAVE ME BY reserved early, angled four wide on the far turn, rallied to gain command at the top of the stretch, then drew away under urging. CHRISTOPHER'SIMAGE unhurried early, swung out for the stretch run and closed to prove second best while unable to match strides with the winner. BERNIE THE MAESTRO tracked the pace, made a run on the far turn to loom a threat racing into the stretch, then tired in the drive. HEAR YE HEAR YE pressed the pace outside ABDEL'S GHOST, took over from that rival on the far turn, made the pace to the top of the stretch, then had nothing left. BARRY'S MONEY was not a factor. MANNY WHO tracked the pace, advanced three wide to reach contention at the quarter pole, then faltered. FULL HORSE POWER was done early and eased in the final eighth. ABDEL'S GHOST set the pace under pressure along the inside into the far turn, then faded and was eased in the stretch run.
