AMBITIOUS BREW stalked outside, came three wide into the stretch, took the lead three deep in midstretch, inched away and held under urging. LAKERVILLE chased a bit off the rail then tugged his way up and tried to go between horses midway on the hill but steadied behind the trees, came out leaving the hill and three deep into the stretch, angled in some past midstretch and finished well. SUMMER HIT broke in a bit, went up between rivals then stalked a bit off the rail, bid between horses in the stretch, could not match the winner late and was edged for the place toward the inside. COACH BOB went up inside to gain the early lead and inched away, set the pace inside, came a bit off the rail in upper stretch, drifted in and fought back in midstretch, then weakened late. AIN'T NO OTHER had speed off the rail then between horses, fell back then moved up inside on the hill but dropped back again, advanced along the rail in the stretch, waited off heels then came out for room in midstretch and lacked the needed late kick. KATE'S EVENT broke a bit slowly, settled inside, came out some in the stretch and was not a threat. Rail on hill at 7 feet.
