The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds.; 119 lbs.; Older 125 lbs.; Non-winners of a Sweepstakes of \$60,000 twice at a mile or over in 2010-2011, allowed 3 lbs.; Of a Sweepstakes of \$60,000 at a mile or over in 2010-2011, allowed 5 lbs.; No n-winners of a Sweepstakes of \$60,000 at any distance in 2010-2011, allowed 7 lbs. (No Canadian Bred Allowance) Final entries to be made through the entry box at the closing time then in effect for overnight events. (Closed with 16 Nominations). MUSKETIER (GER) stalked the pace, was hustled three and four-wide from midway of the far turn, rallied, bid just into the final furlong and prevailed under a drive. GRASSY showed early foot, was headed and settled in to stalk the pace, chased from midway of the final turn, rallied three-wide through the stretch, bid into the final furlong but was outfinished. WINDWARD ISLANDS stalked along the rail, was blocked from the top of the stretch to the final furlong, angled out and responded with a surged in the late stages. SIMMARD raced off the pace, closed early backstretch, engaged the leader midbackstretch, dueled, was headed upper stretch, launched a determined second bid midstretch and drew even but failed to sustain the drive in the final furlong. RAHY'S ATTORNEY led into the dog leg, set a reserved pace, was joined midway of the backstretch, dueled to the top of the stretch and gained a narrow advantage, held to the final furlong and gave way grudgingly. SOLITAIRE raced off the pace, angled out late turn, chased five-wide into the stretch but did not threaten. MIAMI DECO, in range, fell back late backstretch, was hustled through the turn then lacked a rally.
