1 MILE 70 YARDS. (1.383) STAKES. Purse \$350,000 SMARTY JONES S. (GRADE III) FOR THREE YEARS OLD. By subscription of \$350 each which should accompany the nomination, \$700 to pass the entry box, \$1,050 additional to start, with \$350,000 guaranteed to be divided: \$210,000 to the owner of the winner, \$70,000 to second, \$38,500 to third, \$21,000 to fourth and \$10,500 to fifth. Weight: 122 lbs. Winners of an unrestricted sweepstakes in 2012-2013 2 lbs. additional. Non-winners of \$30,000 twice at a mile or over since July 2 allowed 3 lbs. \$30,000 once at a mile or over since then, 5 lbs. (Maiden, Claiming and Starter races not considered). Starters to be named through the entry box by the usual time of closing. A trophy will be presented to the winning owner, trainer and jockey. Nominations closed Monday, August 5, 2013 with 3 0. The winning horse will receive a free nomination, entry and start fee to the 2013 Grade II Pennsylvania Derby. (Showery 75)

EDGE OF REALITY urged to a clear lead, rated kindly, was challenged in the stretch from the outside and held on gamely to the wire. SPEAK LOGISTICS saved ground just off the pace, angled out on the final turn, loomed boldly but could not get by the winner. UNCAPTURED was bumped and bobbed on the first turn, advanced strongly on the rail on the final turn then flattened out in the stretch. BATTIER allowed to settle early, rallied very wide on the final turn and had little further response. MICROMANAGE chased between rivals early and found best stride too late. BETWEENHEREANDCOOL prompted the pace outside then began fading on the final turn. SNAKE PIT chased within striking range then gave way after five furlongs. NORUMBEGA dropped well behind and was never a factor. ENGLISH MANOR prompted the pace for half a mile then stopped. BELLARMINE steadied briefly on the first turn and was finished by the far turn.
