MUSICAL ROMANCE rated off the pace after breaking awkwardly, steadied in behind DERWIN'S STAR on the turn and never threatened. POMEROYS PISTOL tracked the leaders along the inside into the turn and tired. BEAT THE BLUES raced three wide and faltered. DERWIN'S STAR saved ground and faded.
