**BENNY THE BULL** rated off the pace, was steadied from tight quarters on the backstretch and angled to the inside, came around **HIGH STANDARDS** on the turn, slipped through along the rail to gain command at the top of the stretch, then drew off under a hand ride. **SANTANA STRINGS** unhurried early, saved ground and closed to gain the place while no match for the winner. **MACH RIDE** bumped with **HIGH STANDARDS** at the start, pressed the pace off the rail, moved to take over on the turn, made the pace to the top of the stretch, then gave way. **TROPIC STORM** reserved off the pace, advanced three wide on the turn to loom a threat, but had no late response. **MR. UMPHREY** allowed to settle, advanced five wide around the turn to reach contention, then flattened out. **COBALT BLUE** failed to menace after being outrun early. **STORM IN MAY** saved ground to no avail. **FINALLYMADEIT** chased the leaders three wide around the turn and tired. **PRAYING FOR CASH** was done early. **HIGH STANDARDS** bumped with **MACH RIDE** at the start, showed brief speed along the rail and faltered. **BUSHWACKER** chased the pace four wide around the turn and faded.
