SOONER TIME pressed between horses on the backstretch, moved up to bid three deep on the turn, took the lead, opened a clear advantage in upper stretch and remained clear to the wire under a couple of taps of the whip and good handling. **WISH I UNDERSTOOD** stalked inside on the backstretch, steadied between horses leaving the three eighths marker, angled out, came into the stretch three wide, rallied in the final furlong and gained second on the wire. **FAST ESCAPE** came in at the start and bumped a rival, dueled between horses on backstretch and turn, came into the lane between foes and was edged for second on the wire. **VRONSKY'S DEVKA** dueled inside down the backstretch and on the turn and weakened through the final furlong. **DONT TELL JACKIE** stalked the pace three wide on the backstretch, fell back on the turn and weakened through the lane. **MISS AMADOR** stalked the pace three deep on the backstretch, angled in on the turn and did offer a bid in the lane. **AFFIRMED TOWER** broke inward and slowly, chased on the inside and did not threaten. **DANI'S GIRL** chased a bit off the rail on the backstretch and did not rally in the lane. **LIGHTHOUSE LEGEND** was bumped and steadied at the start, chased on the outside, angled in on the turn, came back out at the top of the stretch and did not threaten.
