SWISS LAKE YODELER stalked the pace outside a rival on the backstretch and turn, came three deep into the stretch and rallied under urging to wear down the runner-up in deep stretch to prove best. ROVENNA had good early speed and dueled inside, inched away nearing the turn, fought back a bit off the fence in the stretch, could not quite match the winner late but continued willingly. SPROUTS had speed off the rail then dueled outside the runner-up, stalked into and on the turn, came out some in the stretch, bid again alongside that rival, was between horses past midstretch and bested the rest. MEINERTZHAGENI stalked the pace inside to the stretch, continued along the rail and lacked the needed response. SHYSHEISNOT bobbed at the start, chased between horses on the backstretch and turn and could not offer the needed late kick. KUKALUKA settled off the rail, went four wide into and on the turn and into the stretch and lacked the necessary rally. CASEY'S CLEM pulled her way between horses early, chased a bit off the rail then inside, saved ground on the turn and did not rally. STOLE A KISS broke alertly then stumbled after the start, stalked four wide on the backstretch and into the turn, came three deep into the stretch and weakened. FEATURE ATTRACTION chased between horses on the backstretch and turn, fell back just off the rail leaving the turn and weakened.
