HOT DIXIE CHICK pressed the early pace along the rail, was in hand while easing back slightly at the three-eighths pole, saved ground to the turn, charged through along the rail to take command in upper stretch and edged away under intermittent right hand encouragement. **BEAUTICIAN** forced the pace three wide for a half, lodged a move from outside in upper stretch but was no match for the winner while clearly best of the others. **BICKERSONS** set the pace under pressure between horses to the top of the stretch and tired from her early efforts. **SASSY IMAGE** was well placed just off the pace from five furlongs and lacked a strong closing bid. **MAGIC APPEAL** bobbled and bumped with **SNAP HAPPY** at the start, raced between horses to the turn and lacked a strong closing response. **OPUS A** saved ground while trailing for a half after breaking slowly, drifted out in upper stretch and lacked a late response. **SKY FEVER** saved ground while far back to the turn and failed to menace while drifting out. **SNAP HAPPY** bumped at the start, was outrun for five furlongs, drifted wide at the quarter pole and lacked a further response.
