Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which 60% to the winner; 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to starters sixth through ninth. Weight: 122 lbs. Non-winners of \$36,000 allowed 2 lbs. \$25,000 allowed 4 lbs. \$20,000 allowed 6 lbs. (Maiden and claiming races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. This Stake will be limited to 14 starters should race not be split. Preference to horses that have accumulated the highest lifetime earnings. Different owners have equal draw according to money earned. BIG TEXAS DADDY devoid speed, advanced inside around the turn, angled in nearing mid stretch, rallied but was too late. ENUMERATE settled inside while out footed, was steered out entering the drive, then was game for the show. NORTH OF ALASKA close up, loomed three wide before the drive, then failed to sustain his bid. VITO FILITTO cleared to the inside early, was collared around the turn, got headed and weakened. INSTANT MESSAGE raced wide. ROYAL EXPRESS raced wide.
