1 MILE. (Turf) (1.34) STAKES. Purse \$75,000 (Includes \$75,000 Other Sources) *SUNDAY SILENCE* S. FOR TWO YEAR OLDS. Free nomination. \$375 to enter and an additional \$375 to start. Supplementary nomination of \$2,250 due at time of entry (includes entry and starting fees). \$75,000 Guaranteed of which 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs. Non winners of a sweepstakes at a mile or over allowed 2 lbs.; a race other than maiden or claiming at a mile or over allowed 4 lbs.; a race other than maiden or claiming at a mile or over allowed 6 lbs.; Maidens allowed 8 lbs. In the event that more than twelve (12) pass the entry box, preference will be given to the horses with the highest earnings. Different owners have equal draw according to earnings. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Louisiana Downs will present a trophy to the winning owner. MY POINT EXACTLY unhurried in the early going, racing within striking distance, made a late bid, five wide and got up in time. SYLVAN HILLS BOY pressed the pace on the inside, angled out down the home stretch, finished willingly and was a game second. RIDE N' REEL raced within striking distance, came around the final turn four wide, made a bid, took the advantage down the stretch and was caught late by the top two. IT'LL BE FINE raced in the middle of the pack, eased back, made a late gain and missed third. TASK FORCE GLORY lacked early speed, came around the final turn four wide, angled inside and showed late interest. SHARON'S BOY pressed the early pace, being reserved, came around the first turn three wide, forwardly placed until late, faded. HANEY went to the front, took command, saved ground and was finished early. SERIOUS FUN always raced near the back and showed little.
