STAR HARBOUR broke sharply to set a pressured and quick pace on the inside, spurted clear on the turn and into the lane, had a clear advantage mid-stretch at which point the rider looked back for challengers, gave his steed a few right-handed reminders, and had enough left to maintain an advantage to the wire. JACKSON BEND settled off the pace early, raced three to four wide on the turn, hit his best stride late and was gaining but couldn't reach the winner. BAHAMIAN SQUALL stalked from a good position, traveled three wide around the turn, was put to a drive at about the quarter pole, was all out through the lane but was unable to hold the place. CLOSE IT OUT raced four wide on the turn, five wide into the lane, evenly. FORT LOUDON was hustled along early while chasing from the rail, weakened, had no apparent excuse. CAT FIVE HURRICANE pressed the pace from the outside, was eased mid-turn, vanned off.
