VICAR'S IN TROUBLE reserved on the front end, forwardly placed throughout, dueling with IDE BE COOL, pulled away down the final stretch and won handily. DECLAN'S FAST CAT lacked early speed, made a late inside bid, came out down the stretch, proved no match for the winner, but got up for second. VICTORY NOR DEFEAT raced in the middle of the field, made a late bid and was outfinished for second. IDE BE COOL dueled on the front end, forwardly placed throughout, saved ground and lacked a late kick. JESSICA'S STAR raced within striking distance, saved ground around the second turn, steadied slightly down the stretch and lacked a finish. EAST HALL lacked early speed, moved up around the final turn, steadied at the head of the stretch, getting in tight quarters and finished evenly. LOUISIANA FLYBOY void of early speed, came around the final turn five wide, came in at the head of the stretch and was never a factor. ANNOUNCEMENT raced evenly near the back and was never a threat. LOUIES FLOWER pressed the early pace and dropped back. ALAMO HEIGHTS raced near the middle of the field and retreated. GOLD APPOINTMENT challenged for the early advantage, came around both turns three wide, steadied at the head of the stretch and was outrun..
