DOUBLES PARTNER was unhurried early, fanned five wide out of the second turn then closed fast to be up in the final strides.

RAHYSTRADA raced close up early, bid in mid stretch to gain the lead inside the final furlong only to be caught on the wire. VOODOO SWINGE was void of early speed, fanned widest of all in the drive then closed with a rush to just miss. BEARPATH made a middle move after five furlongs then closed fast between rivals to be going well late. TEAKS NORTH raced inside to the quarter pole, swung to the middle of the course to be in striking distance in the drive but was outfinished late. YANKEE INJUNUITY set a solid pace past mid stretch before slowly weakening. DON CAVALLLO pressed the pace to the stretch then flattened out. VANQUISHER clipped heels early. UNION BOWMAN chased uncovered for six furlongs then stopped. TANNERSVILLE stopped. There was a stewards inquiry conducted into the race after the start before the results were declared official.
