FAST ALEX was well placed just off the pace, moved out leaving the backstretch, ranged up while three wide on the far turn, made a four wide bid at the quarter-pole, dueled with GLEAM OF HOPE while on the outside, bumped with that rival near the sixteenth-pole, continued the resolute duel and gamely prevailed. GLEAM OF HOPE settled on the inside while well behind the field, moved closer on the far turn, made a rail bid in upper stretch, dueled on the inside of FAST ALEX, bumped with that rival near the sixteenth-pole, battled gamely to the wire but just missed. PROSPECT KNIGHT went two then three wide on the first turn, moved to four wide nearing the backstretch, settled on the outside, was urged along while three to four wide on the far turn, came five wide into the stretch and narrowly earned the show. MAXIMUS RULER broke out at the start, raced four wide on the first turn, tracked the pace, vied outside on the far turn, proved no match for the top two then just missed the show. SWEETSOUTHERNMOON set the pace through moderate fractions, lost the lead near the quarter-pole and gave way.
