PRAYER FOR RELIEF was well placed on the inside while under some restraint, inched closer midway down the backstretch, took the

lead along the rail entering the far turn, was asked once straightened for the drive, came under the whip shortly thereafter and drew off under

steady urging. GROUND TRANSPORT set the pace while off the rail, lost the lead leaving the backstretch, dropped back near the

five-sixteenths pole, chased into upper stretch and proved no match while just able to get the place. AGENT DI NOZZO settled on the inside, was ridden along on the far turn, moved out under a drive near the furlong marker and just missed the place. GRAND CONTENDER was away

awkwardly, went three wide on the first turn, tracked the pace on the outside, raced three wide on the far turn, was asked near the five-sixteenths pole, chased into upper stretch and tired. VOODOO STORM raced off the rail on the first turn, settled off the pace, bumped

lightly with a rival outside the seven-sixteenths pole, came under urging on the far turn, shifted three wide into the stretch and lacked the needed response. AFFORD brushed with a rival entering the first turn, was hard held while two to three wide on that bend, raced off the pace while under heavy restraint, bumped lightly with a rival outside the seven-sixteenths pole, was asked while two to three wide on the far turn, shifted five wide approaching the quarter-pole and also lacked the needed response. FLASHY SUNRISE went three wide on the first turn,

settled on the outside, moved closer with a half-mile to run, was urged along while four wide on the far turn and came up empty. HIP FOUR SIXTYNINE brushed with a rival entering the first turn, settled towards the rear, was urged along while three to four wide on the far turn, moved to six wide nearing the quarter-pole and failed to threaten.
