INNER TURF FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD FOALED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. A supplemental nomination fee of \$1,500 may be paid at time of entry. \$1,500 to pass the entry box. A II starters including supplements are required to pay all fees and will receive a \$1,000 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 120 lbs. Older, 123 lbs. Turf weights: Non-winners of \$60,000 on the turf in 2009 allowed 2 lbs.; a sweepstake on the turf in 2009, 4 lbs.; three races on the turf, 6 lbs. Dirt weights: Non-winners of a sweepstake on the dirt in 2008-09 allowed 2 lbs.; \$30,000 on the dirt in 2008-09 or four races on the dirt, 4 lbs.; three races on the dirt, 6 lbs.(Maiden,claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. Closed Saturday, October 10, 2009 with 36 Nominations. (Clear 60)

YOU GO WEST GIRL raced just off the early pace between horses, steadied in traffic at the half mile pole, raced between horses to the turn, altered course to the outside in upper stretch and unleashed a strong late run to win going away. LOVE COVE pressed the pace in the two path, battled into midstretch and held well for the place. NEHANTIC KAT steadied along the rail on the first turn, settled in good position while saving ground, split horses in traffic in midstretch and finished willingly. CHESTORIA was reserved for six furlongs, advanced between horses on the turn and rallied belatedly. BORROWING BASE raced well back along the rail to the turn and rallied mildly. REMARKABLE REMY raced within striking distance four wide to the top of the stretch and lacked a strong closing response. OUR GOLDEN DREAM saved ground early, angled out on the turn and finished evenly. YET AGAIN raced in midpack four wide for six furlongs and steadily tired thereafter. ONE IN A ROMP angled in after breaking slowly then saved ground to no avail. ACQUIRED CAT set the pace along the rail into midstretch and gave way. THEM THERE EYES never reached contention. LOVELY DANIELLA chased three wide, lodged a bid from outside on the turn and flattened out.
