MISS DEJAVU a bit reluctant to load, broke in, made a sudden move on the outside to wrest control turning for home, drifted in while a bit green when straightened for home, held the runner up at bay late while under steady handling. KNOX COUNTY ZIP broke sharp with some encouragement despite a slight bump, vied closest to the inside, headed midway on the turn, asked for run, surpassed by the winner with a quarter mile remaining, moved out a bit when set down for the drive, could not get back to that rival, second best. HALO OF DREAMS lacked early pace after not breaking with the field, came four wide out of the turn, set down for the drive, rallied for the show. YARMORKA within striking distance, moved a bit closer late in the turn while three wide, lacked a further bid in the drive to be caught late for the show. CARMEN'S SECRET bumped slightly with the runner up at the break, settled off the leaders and went one paced throughout toward the inside. IMAGE OF RACHEL shuffled back at the start, raced back early as a result, improved slightly in the drive without posing a serious threat. HEADING SOUTH last away, picked off a couple of tiring rivals while never a threat. DIANA'S COMPRISE was never a factor. ANOTHER GRAND SLAM brushed start, dueled outside the runner up, stopped in the drive.
