The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. TEEN PAULINE lost her footing leaving the starting gate, showed no ill effects and quickly established control, settled along the inside route by the top of the opening bend, picked up the pace a notch after dawdling along in the early stages, picked in up much noticeably after completing the half, entered the stretch with none latched on, remained comfortably in the clear, finishing the final seventy yards under a brisk hand ride. CENTRING was unhurried while racing two wide for nearly three-quarters, swung four wide into the stretch, got straightened away and came home with good energy to procure the place. FLASH FORWARD sat patiently in the pocket, was put to strong encouragement by the midway point on the far turn, angled out for the stretch drive, swerved out past the three-sixteenths pole, bumping lightly with ROYAL LAHAINA, got outfinished. ROYAL LAHAINA raced three wide on both turns, was under urging for a good portion of the way around the second one, made slight contact with a momentarily-errant FLASH FORWARD prior to arriving at the furlong marker, flattened out. FLORES ISLAND stalked the winner from the two path, undertook the task from between rivals on the second bend, tired.
