GREAT HOT (BRZ) chased outside a rival, came out some in the stretch, was three wide in deep stretch and rallied under urging to wear down the runner-up. SUGARINTHEMORNING stalked off the rail, bid alongside a rival leaving the backstretch and on the second turn, took the lead into the stretch, inched away and drifted inward in midstretch and held on well but was run down late. CATHY'S CRUNCHES saved ground chasing the pace, cut the corner into the stretch, came out in late stretch and went willingly to the wire. LONG LAKE KRISTA sent between horses early, angled in and set the pace inside, dueled along the rail leaving the backstretch and through the second turn and into the stretch, came off the fence in midstretch and weakened. LOVE THEWAY YOUARE stumbled at the start, settled off the rail trailing the field, came out into the stretch and lacked the needed rally. JELLY CABLE settled outside a rival then along the inside, came a bit off the rail on the second turn and did not rally.
