Non winners of \$60,000 at a mile or over since May 19 allowed 3 lbs; non winners of two races other than maiden, claiming or starter at a mile or over since August 19 allowed 5 lbs; Non winners of such a race since August 19 allowed 7 lbs. Preference will be given to horses with the highest earnings in 2010-2011 (at time of entry). Different owners will have equal draw according to preferences. FOOLS IN LOVE vied for the lead while two wide, was in a long drive then weakened in the stretch. LE MI GEAX vied for the lead while three wide, was in a long drive while being used up and gave way. WARPAINT ANNIE vied for the lead from the inside, was hard used into the far turn and gave way.
