GIRL BAR broke in the air, moved up to chase the pace three wide into the stretch but couldn't gain on the winner late. GESU chased the pace after bumping with CRUZIN WITH CASH in the early going, advanced along the hedge to loom a threat in midstretch, then weakened. CONCORDE'S FURY well placed into the stretch, lacked a late response. OVERTOWN pressed the pace outside RETIRE TO WHAT into the stretch, then gave way. TUTOR reserved after bumped with CRUZIN WITH CASH in the early going, raced three wide around the turn and failed to menace. CRUZIN WITH CASH bumped between rivals in the early going, saved ground around the turn and tired. SHARKBAIT OOH HAHA was no factor after hesitating at the start.
