By subscription of \$150 each which shall accompany the nomination and an additional \$1,500 when making entry. The purse to be divided: 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: Three-Year-Olds 122 lbs.; Older 124 lbs. Non-winners of a Sweepstakes of \$75,000 three times at a mile or over in 2009, allowed 3 lbs.; Of a Sweepstakes of \$75,000 twice at a mile or over in 2009, allowed 5 lbs.; Of a Sweepstakes of \$75,000 once at a mile or over in 2009, allowed 7 lbs.; Of a Sweepstakes of \$60,000 once at a mile or over in 2009, allowed 9 lbs.; Of \$52,740 at a mile or over in 2009, allowed 11 lbs. Chestnut Gelding, (May), by Lord Avie - Cloudy Spot by Solar City. Trainer Sheppard E. Jonathan. Bred by Jerrold Schwartz(KY). CLOUDY'S KNIGHT, always in range, pulled to the lead along the rail passing the wire the first time, drew off a bit, set a reserved pace, was headed nearing the final turn, stalked the leader then rebid late turn, dueled through the stretch then moved clear late under a hand ride. EAGLE POISE raced off the pace, closed on the backstretch the second time, took the lead into the final turn, was engaged late turn, dueled through the stretch but was no match in the late stages. POOL PLAY raced midpack, closed late turn, was all out through the stretch but hung late. TORQUAY raced well back, closed on the backstretch, pressed the pace through the final turn but couldn't stay close turning for home. RED LEADER stalked the early leaders then settled off the pace, chased on the far turn but never reached contention. SOLITAIRE raced midpack, chased into the stretch but evened out. GUADALCANAL, unhurried to the final turn, chased to the stretch then flattened out. COBOTOWN RON was unhurried early, was roused on the final turn but lacked a closing response. FIND THE WIRE showed brief speed then settled off the pace, was shuffled back nearing the far turn and failed to menace. AUTEUR vied briefly, led to the 3/4, was passed, stalked to the far turn and tired.
