BYRAMA (GB) stalked inside then a bit off the rail on the second turn, bid between horses a quarter mile out, took the lead nearing the stretch, inched away in the drive then drove clear in the final furlong under urging. MORE CHOCOLATE saved ground chasing the pace, came a bit off the inside on the backstretch, bid three deep leaving the second turn and into the stretch, could not match the winner in the final furlong but held second. LADY OF FIFTY unhurried and angled in a bit off the rail in the run to the first turn, moved up toward the inside on the second turn, swung out into the stretch and bested the others. ROYAL TIGER had speed three deep then kicked clear and angled in, set the pace inside, dueled leaving the second turn and weakened in the stretch. OPEN WATER settled off the rail then chased outside a rival, came out into the stretch and weakened. ESENTEPE (IRE) had speed between horses then stalked outside a rival, dropped back leaving the backstretch, angled in on the second turn, gave way and was eased in the stretch.
