The added money and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 123 lbs. SARA LOUISE settled in good position, closed the gap four wide at the quarter pole, made a run to threaten in midstretch and wore down the runner-up under left hand urging in the final seventy yards. BOLD UNION set the pace under pressure along the rail into deep stretch and yielded grudgingly. JULIET'S SPIRIT pressed the pace in the two path for most of the trip and weakened in deep stretch. SKY HAVEN raced well back for a half, angled three wide entering the stretch and closed late in the middle of the track. TRIx IN THE CITY failed to mount a serious rally while saving ground throughout. ALL OF HER TWIST raced up close along the rail, lodged a mild bid in upper stretch and steadily tired thereafter. STEP OUT SMARTLY was outrun along the rail after breaking slowly and rallied belatedly. SELVA raced just off the pace between horses to the turn and faltered. REFORESTATION was never a factor while wide throughout.
