BABY J hustled from the start, cut the pace from the three path under some pressure early from BRIDGEHAMPTON, dueled with that foe

through the turn getting headed at the five-sixteenths as she made her way to the two path, got set down at the head of the lane, had her main foe drift in bumping her at the three-sixteenths, paused briefly to allow that one by under confident handling as that foe drifted in front, angled out nearing the eighth pole, came again from the outside to get up in the final strides and prevail in a determined effort. BRIDGEHAMPTON keen early on fighting the bit against the restraint of the rider, ranged up to duel through the turn from the four path, shifted in a path taking command at the five-sixteenths narrowly, got placed to encouragement swinging into upper stretch, drifted in bumping her main foe at the three-sixteenths appearing still a bit green, inched clear continuing inward a path or so to the eighth pole under a drive, dug in confronted by

that same rival through the final eighth now from the outside, fought on to the finish with good energy but was caught in the final strides. FUSAICHISWONDERFUL brushed the near side stall at the start, chased inside urged along from three furlongs out, cut the corner into the stretch, offered up a mild bid for the show honors. TEEN PAULINE hit the near side stall at the start, chased from just off the inside ridden along from midway on the turn, drifted a bit three wide at the quarter pole and came up empty. I'M MOM'S FAVORITE broke out at the start and was corrected, chased four wide throughout urged along from the three-eighths pole and weakened in the drive.
